## Terms and Conditions

**ASSIGNMENT** This Agreement may not be assigned, or the rights granted hereunder transferred or sub-licensed, by either party without the express prior written consent of the other party.

**ENTIRE AGREEMENT** This Agreement: (i) supersedes and replaces all prior agreements, oral and written, between the parties relating to the subject matter hereof; and (ii) be amended only by a written instrument clearly setting forth the amendment(s) and executed by both parties.

**GOVERNING LAW** All questions with respect to the construction of this Agreement or the rights and liabilities of the parties hereunder shall be determined in accordance with the laws of the State of Pennsylvania. Any legal action taken or to be taken by either party regarding this Agreement or the rights and liabilities of parties hereunder shall be brought only before a federal, state or local court of competent jurisdiction located within the State of Pennsylvania. Each party hereby consents to the jurisdiction of the federal, state and local courts located within the State of Pennsylvania.

**TERMINATION** The Sponsor may terminate its membership at any time by providing AMSP with written notice requesting such termination. AMSP may terminate the Sponsor's membership if the Sponsor violates or fails to comply with any of the terms and conditions of membership established by AMSP. The Sponsor understands that no portion of its membership fee will be refunded if its membership is terminated for any reason.
